
Jackson MPO Approves 2023-2026 TIP and 2023-2024 UPWP Documents



In August, the Jackson Metropolitan Planning Organization (MPO) approved the 2023-2024 Unified Planning Work Program (UPWP) and the 2023-2026 Transportation Improvement Program (TIP).

The TIP is a multi-year listing of transportation projects within the Jackson Metropolitan Area with a commitment of funding from a combination of federal, state, and/or local sources. The TIP serves as a shortterm planning document that lists approximately four (4) years of federally or regionally significant funded transportation projects designed to carry out the recommendations of the region's long-range Metropolitan Transportation Plan. The projects include various capital and operating needs of the region including reconstruction; maintenance and operation of major highways, arterials, collectors, and intersections; maintenance of public transit services, and construction of bicycle and pedestrian improvements.

All projects that have received a commitment of federal transportation funds, along with non-federally funded projects that are regionally significant,



are included in the TIP. The TIP lists all project phases and the anticipated implementation schedule for those phases for each included project. Project phases can include preliminary engineering, design, environmental review, right-of-way acquisition, and construction. The TIP is required to be realistic in terms of available funding. Meaning the projected amount of expenditures does not exceed the projected amount of revenue each year. The 2023-2026 Jackson Urbanized Area TIP covers the timeframe of October 1, 2022, to September 30, 2026. By federal law, the TIP is required to be updated at least every four (4) years, but the Jackson MPO typically updates its TIP every two (2) years. The TIP document as well as an interactive TIP map is available for review on CMPDD's website, http://cmpdd.org/transportationimprovement-program-tip/.

The Unified Planning Work Program (UPWP) describes all transportation

planning activities to be performed by the CMPDD as the designated MPO and JTRAN as the designated public transit provider during fiscal years 2023 and 2024 (October 1, 2022, through September 30, 2024). It includes a listing of major activities and tasks anticipated to be performed including details on who will complete the work, the schedule for completing the work, the resulting planning products, and a summary of the proposed funding sources. The 2023-2024 UPWP contains four (4) major program areas with associated subtasks for each including:

- Transportation Planning Process Program Administration
- System Planning
- Data Collection and Analysis
- Support Activities

CMPDD Applies for SS4A Grant Funding

The Central MS Planning and Development District (CMPDD) has submitted a Safe Streets and Roads for All (SS4A) grant application on behalf of CMPDD's seven-county region. This U.S. Department of Transportation (USDOT) grant opportunity was created under the Bipartisan Infrastructure Law and provides \$5 billion in grant funding spread over the next Five (5) years.

The SS4A program supports the USDOT's goal of zero (0) deaths and serious injuries on the nation's roadway. If awarded, the grant will support CMPDD's effort to develop a comprehensive seven-county safety action plan. The Plan's development

will include conducting a detailed analysis of crash data to identify locations, patterns, and types of serious crashes in CMPDD's seven-county region. The results of the detailed analysis along with public outreach efforts will be used to identify a prioritized strategy of policy changes and potential projects aimed at saving lives on the region's roadways.

The purpose of the SS4A grants is to improve roadway safety by

significantly reducing or eliminating roadway fatalities and serious injuries through safety action plan development and implementation of projects focused on all users, including pedestrians, bicyclists, public transportation riders, motorist, and commercial vehicle operators.

USDOT anticipates announcing grant awards in January 2023.



Hazard Mitigation Plan Approved for Hazlehurst

On September 16th, 2022, the Hazlehurst Hazard Mitigation Plan update coordinated by CMPDD on behalf of the City of Hazlehurst was fully approved by FEMA (Federal Emergency Management Agency). The plan will be good for five (5) years through September 15, 2027. It will make the city eligible to apply for the Hazard Mitigation Grant Program, Flood Mitigation Assistance, and Building Resilient Infrastructure and Communities.



Redistricting Update

The District received the 2020 Census population data in September 2021 and began an analysis to determine which jurisdictions are in need of redistricting. The process involves utilizing the District's GIS system to overlay current municipal ward lines and county supervisor and justice court districts over the new 2020 Census population data to determine where changes are needed.

CMPDD has contracted with 20 jurisdictions to develop redistricting plans. These include six (6) counties, thirteen (13) municipalities and one (1) school district. To date, a total of nine (9) plans have been adopted and two (2) are under consideration.

The next phase of this project will involve meeting with election officials to redraw voting precincts based on the changes to election districts.

The Planning Corner Update

CMPDD presented the results of an online survey to the Pearl River Valley Water Supply District's Board of Directors in September as well as an initial draft of a Land Use Plan. The survey received over 1,200 comments which directly impacted the development of the Land Use Plan. Additionally, meetings with overlapping jurisdictions, specifically Rankin County and City of Ridgeland, were held to discuss the common interest in land development within PRVWSD, which also influenced the Land Use Plan. A public draft of the Master Plan is expected in early November.

Work continues on the City of Brandon's Comprehensive Plan as a public input survey has been released and an initial draft of the Land Use Plan and Transportation Plan is underway. These drafts are based on input received from meetings with department heads, a review of existing land use data, and conversations with the Mayor and Board of Alderman on necessary revisions.


Planners are working with Rankin County on an update to their Comprehensive Plan and Zoning Ordinance. The existing land use survey was completed and is being analyzed. An online survey was conducted as a method of public engagement.

CMPDD planners completed the existing land use survey for Simpson County as the first step in an update to their Comprehensive Plan. The next phase will include meeting with the Simpson County Planning Commission to develop goals and objectives for the plan.

CMPDD Planners continue to field numerous questions and provided guidance on zoning amendments because of the Mississippi Medical Cannabis Act becoming law. CMPDD planners continue to study the Act and have sought guidance on the regulatory authority, including zoning, provided to local governments through the Act. Our planners remain available to member governments as local decisions are considered.

Traffic Count Viewer Updated

District staff, in cooperation with the Mississippi Department of Transportation (MDOT), collect traffic count data on all functionally classified roadways in the Jackson Urbanized Area (JUA), which includes portions of Hinds, Madison, and Rankin Counties on a three-year cyclical basis. At the end of each year all traffic count data collected by District Staff is submitted to MDOT for analysis. This analysis includes reviewing the submitted data to ensure there are no irregularities or "bad data" and then applying traffic adjustment factors to the raw data to develop Annual Average Daily Traffic (AADT) counts. The traffic adjustment factors used by MDOT to develop AADT counts takes into consideration high and low daily and seasonal traffic patterns to arrive at a more representative "annual" traffic count for each location. In the interim years, when traffic count data is not collected for select locations, an estimated count for those locations is developed using existing historical traffic count data and applying estimation factors. Once the MDOT has completed its analysis and developed interim year estimates the updated data for the Jackson MPO Planning Area is provided to the District and made publicly available through our traffic count viewer.



In August District staff updated the traffic count viewer to include all traffic count data for 2021. The traffic count viewer includes not only data for 2021, but also data from 2011-2019. As can be seen on the viewer, traffic count data for 2020 is not included. Due to substantial irregularities in traffic patterns, resulting from the COVID-19 shutdown in 2020 this data was excluded.

Hazard Mitigation Planning Continues

CMPDD has a long history of assisting member governments, universities, and the MEMA District 5 Region with Hazard Mitigation planning and is currently assisting numerous governments with updates to their Hazard Mitigation Plans. The Disaster Mitigation Act of 2000 requires local jurisdictions to maintain an approved Hazard Mitigation Plan to maintain grant eligibility for certain pre- and post- disaster grant programs available through the Mississippi Emergency Management Agency (MEMA) and the Federal Emergency Management Agency (FEMA). In addition, Plans are required to be reviewed and updated every five (5) years to account for any changes that might have occurred that could increase or decrease a community's risk to a particular hazard.

Predicting where the next disaster will occur, and how severe its impact will be on a community is difficult. Given the right conditions natural disasters, such as tornadoes and flash floods, can occur at anytime and anyplace. Their human and financial consequences can be significant. Mitigation Planning is intended to assist communities in determining their risks to natural disasters and developing an action plan to address the known risks by lessening the impact of natural disasters when they do take place.

CMPDD Assists with Annual Chancery Clerks Association Convention

District staff assisted in planning the 2022 Annual Chancery Clerks Association Convention. The Convention was held in Natchez, MS. This convention was attended by almost 60 Clerks from all over the State of Mississippi. The Clerks enjoyed special events in Natchez, as well as

attending educational sessions lead by the State Department of Audit, the Mississippi Personnel Board, and the State Department of Mental Health. This is the second year that District staff has assisted in the planning and implementation of this event.

CMPDD's Medicaid Waiver Program Update

The Elderly & Disabled Medicaid Waiver (E&D Waiver) is a statewide program designed to provide in-home assistance to qualified Medicaid beneficiaries. Beneficiaries must be 21 years of age or older. They must qualify by either SSI Medicaid or 300% of SSI Medicaid. They must require assistance with Activities of Daily Living (ADLs) such as bathing, dressing, eating, ambulation and/or transferring or Instrumental Activities of Daily Living (IADLs) such as laundry, light housekeeping, errands, and/or assistance on community outings. Registered Nurses (RN) and Licensed Social Workers (LSW) work together as a team to case manage Medicaid eligible beneficiaries.

CMPDD currently employs 24 Case Management teams. We are working in partnership with CMPDD's Workforce Investment division to launch a new program targeting Social Workers who have received their bachelor's degree in Social Work and are seeking to work as a licensed social worker case manager. This program consists of exposure to actual job requirements of the Case Managers. It also provides

for and allows dedicated study time, information, and preparation for taking the licensure exam. The LSW trainee program consists of a 12-week period of studying, preparing for the licensure exam, and accompanying established Case Managers on home visits while receiving compensation during the training period. Trainees also receive the traditional benefits of insurance coverage, leave time accrual, and other employee benefits. At the end of the 12-week training period, and passing the licensure exam, the trainee will automatically transition to a permanent LSW Case Manager position.

The Division of Medicaid continues to operate under a federally approved Public Health Emergency (PHE) due to the COVID-19 pandemic. During the PHE, Case Management flexibilities remains in effect: Monthly CM contact visits may be conducted via telephone or video conference; (2) Recertification, Transfer, or Readmit assessments must be conducted faceto-face; (3) Face-to-face visits must be conducted if the beneficiary is

unable to communicate by telephone, if the beneficiary has unmet needs that cannot be resolved by telephone, if risks or reports of abuse, neglect, or exploitation is identified, or if the beneficiary or representative cannot be reached by telephone; and (4) With proper documentation, "Verbal Consent" may documented in lieu of the beneficiary's or representative's original signature. E & D Waiver's personal care attendant, in-home respite and adult day care, and homedelivered meal providers continue to provide services as required.

Quarterly Association Meetings



Representative De'Keither Stamps, President of the Central Mississippi Development Company, Inc. (CMDC), announced the approval of no new loans.

CMDC is a commercial lender certified by the U. S. Small Business Administration and works with local banks and other financial institutions in providing debt capital for small businesses. CMDC provides fixed rate low interest long term financing for small businesses and saves thousands of dollars in debt service on fixed assets. This type financing removes the problem of variable rate financing on long term assets. Many economic forecasters are certain that interest rates will rise. These predictable interest rate increases will not negatively impact the cash flow of those small businesses that have fixed rate low interest loans through the U. S. Small Business Administration's (SBA) 504 Loan Program. The most recent fixed interest rates under this loan program were:

Also, CMDC serves as the Loan Review Board for the Central Mississippi Planning and Development District's (CMPDD's) Minority Business Enterprise Loan Program (MBELP). The MBELP receives its funding from the Mississippi Development Authority (MDA). The interest rate on loans made through this program to a minority owned business is currently 3.25% per annum. The term of a loan can be up to 15 years depending on the use of the loan proceeds (commercial buildings, equipment, inventory, working capital, etc.)

Department of Environmental Quality (DEQ) ARPA Match Grant Program

This Mississippi summer, Environmental Department of Quality announced the Mississippi Municipality and County Water Infrastructure Grant Program. This allows municipalities opportunity to apply for matching funds on their ARPA awards exclusively for water infrastructure projects. District staff assisted many municipalities with their applications in September. District staff will be available to assist again with applications once the second round of the program opens in the spring.

Internship Program Helps Turn Job into Career Opportunity

The workforce division partnered with Nissan North America in Canton to offer a summer internship to current Community College students. This internship is designed to help students still enrolled in school gain experience in their area of study before taking the final steps into full-time employment. Additionally, this work experience offered students an opportunity to implement the technical skills that they were learning in their classroom instruction.

Seven (7) students from Hinds Community College, Holmes Community College, and Copiah-Lincoln Community College successfully completed the 320-hour paid internship program at the Canton plant. Internship wages were paid through the Workforce Innovation and Opportunity Act (WIOA).

All students who completed the internship will return to their respective Colleges to complete their degrees. Nissan has expressed interest in offering the interns full-time employment upon graduation.
