

## Jackson Metropolitan Planning Organization (MPO) 2023 – 2026 Transportation Improvement Program Administrative Modifications and Amendments

Revisions to an adopted Transportation Improvement Program (TIP) are processed through the use of amendments or administrative modifications. These revisions can include adding a new project, deleting a project, moving a project phase forward or backward, increasing or decreasing available funding or revising the projects scope of work. Below is a list of revisions made to the Federal Fiscal Year (FFY) 2023-2026 Jackson MPO Transportation Improvement Program since the original document was approved in September 2022 by the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA).
