**Administrative Modifications and Amendments**

Revisions to an adopted Transportation Improvement Program (TIP) are processed through the use of amendments or administrative modifications. These revisions can include adding a new project, deleting a project, moving a project phase forward or backward, increasing or decreasing available funding or revising the project's scope of work. Below is a list of revisions made to the Federal Fiscal Year (FFY) 2025-2028 CMPDD MPO Transportation Improvement Program since the original document was approved in September 2024 by the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA).
