CMPDD SEEKS COMMENTS ON PROPOSED CHANGES TO THE 2025-2028 TRANSPORTATION IMPROVEMENT PROGRAM

The Central Mississippi Planning & Development District (CMPDD), on behalf of the Metropolitan Planning Organization (MPO), invites all interested citizens and stakeholders to review and provide comments on proposed amendments to the 2025-2028 Transportation Improvement Program (TIP). The TIP is a federally required planning document that identifies a multi-year listing of planned transportation improvements that have received a commitment of federal, state, and/or local funding. The TIP includes projects related to highways, bridges, transit, bicycle and pedestrian facilities, and other transportation improvements.

The **public comment period** for the proposed amendments **will begin Wednesday, August 5, 2026, and will remain open through Friday, August 14, 2026, at 5:00 p.m.** All comments received during this period will be considered by the MPO on the proposed amendments. The proposed amendments are attached to this notice and are also available for review on the CMPDD website at www.cmpdd.org/transportation/get-involved/

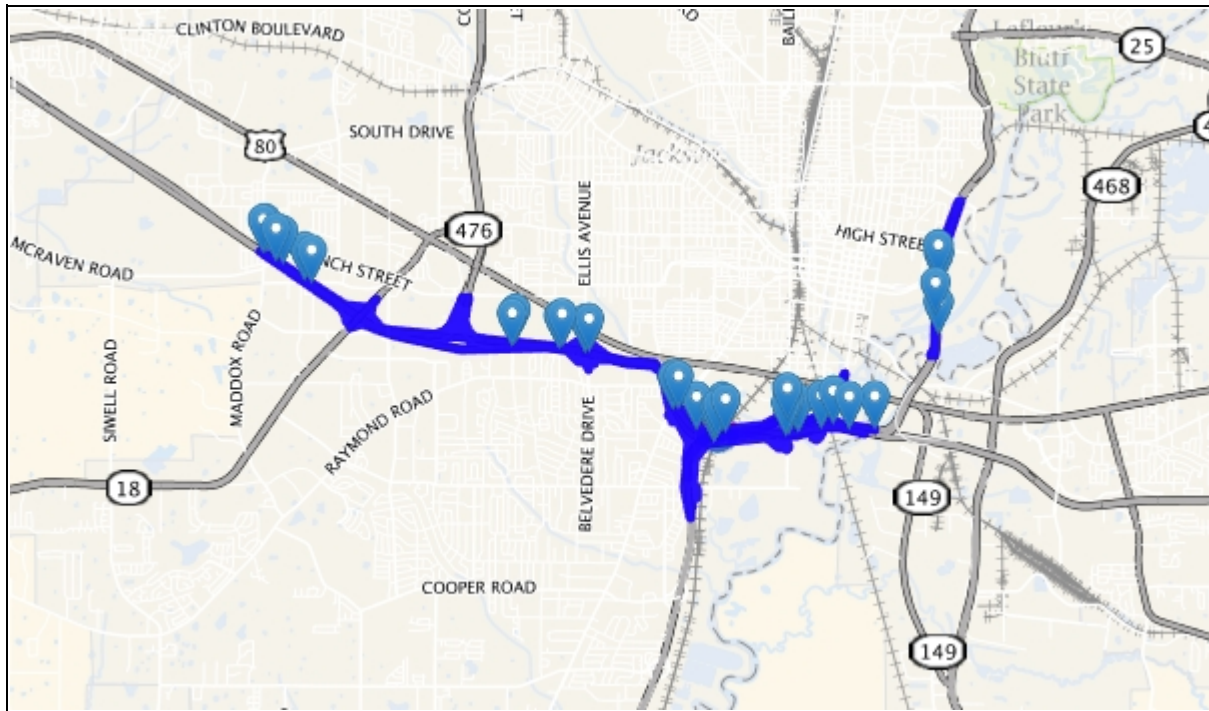

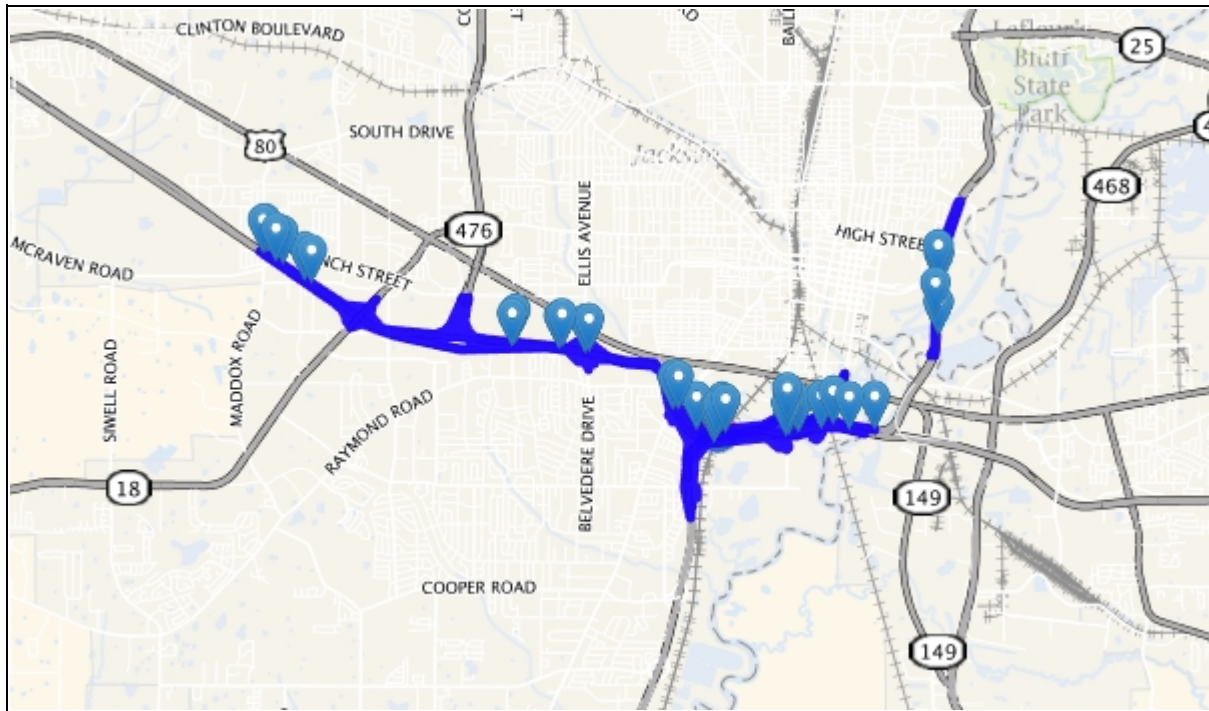
